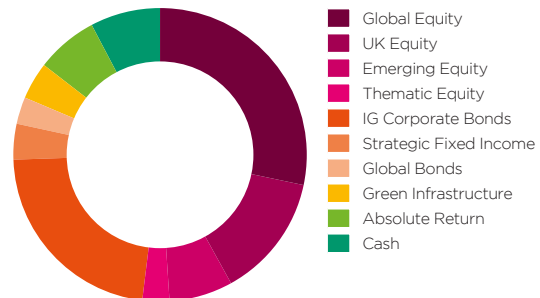

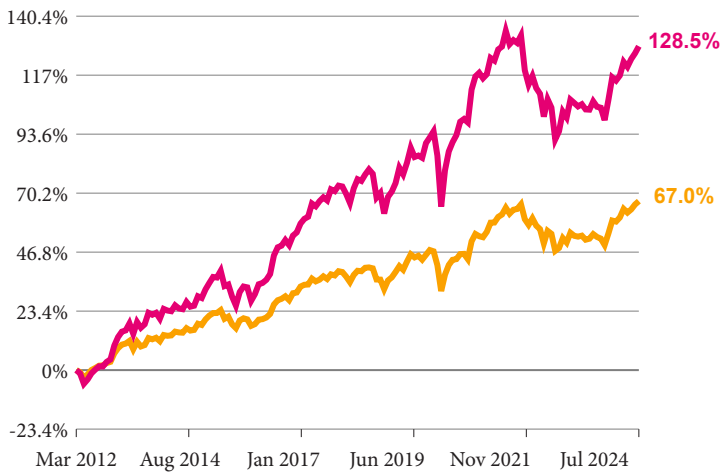

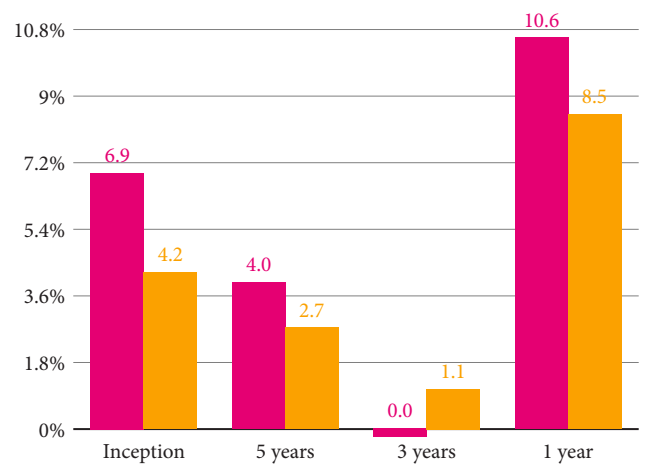
Pacific Sustainable Balanced Portfolio GBP from 30 Mar 2012 to 31 Jul 2024
